- g. Re-cuts requested within two business days after delivery will be provided at no additional charge, provided there are no changes to the content of the Project.
- h. Client shall provide to Talent a copy of the finished Project and grants permission to Talent to use the finished Project on Talent’s website and/or demo reel.
- i. Client waives any conflict of interest, if any, that may be created by Talent recording similar projects for other clients involving competing products or services.

- j. Talent is an independent contractor and not an employee of Client for federal income tax and all other purposes.
- k. Client warrants that it has the right to use the content of the Project for the purposes specified above and warrants that the content does not violate any laws. Client agrees to defend, indemnify and hold Talent harmless from and against any claim relating to the content of the Project.
